Terms of Reference (TOR) for Occupational Safety And Health Audit

1. Introduction and Overview

Action Africa Help International (AAH-I) is a regional African-led non-governmental organisation that supports livelihood-challenged communities in East and Southern Africa to sustainably improve their well-being and standard of living. With Country Programmes in Kenya, South Sudan, Uganda, Zambia, Somalia, Djibouti and Ethiopia. AAH-I has over 25 years' experience working with communities in conflict and post-conflict situations, including refugees, internally displaced people and host communities. More recently AAH-I has expanded its activities to work with other marginalised communities including pastoralists and urban slum dwellers.

Action Africa Help International, Kenya Programme (AAH) Kenya, is addressing development challenges in partnership with marginalized Kenyan communities mainly living in low income urban and rural settings including Arid and Semi-arid Areas (ASALs).

In 2012, the programme launched an expanded mandate covering more interventions and other regions in Kenya. Most recently, AAH Kenya programme has expanded to incorporate the Mara Enterprise Development project that is a two-year project that aims to support development of an 'entrepreneurial mind-set' in community members and is primarily working with livestock keepers, women traders and the youth to improve their economic well-being. The programme is also implementing a livelihoods project in agriculture working with refugees in the Kakuma Refugee Camp in Turkana County funded by UNHCR.

The workforce in AAH includes office staff, drivers and housekeepers. AAH employs a large majority of host community.

OSHA 2007 stipulates that the occupier (Employer) of a workplace shall cause a thorough safety and health, risk assessment and fire risk assessment audits of his workplace to be carried out at least once in every period of twelve months by a registered safety and health and fire audits advisor who shall issue a report of such an audit containing the prescribed particulars to the occupier on payment of a prescribed fee and shall send a copy of the report to the Director of the Directorate of Occupational Safety and Health Services.

Action Africa Help International Kenya Programme (AAHK) would therefore like to engage a reputable company to carry out an occupational safety and health audit for its offices in Mara, Narok County and Kakuma, Turkana West County.

2. Specific objectives

The specific objectives of this assignment will be:

- a) To propose recommendations (if any) for existing and potential safety and health concerns
- b) To fulfil the legal requirements as outlined in OSHA 2007 and Legal Notice No. 31/2004, and submit an audit report to DOSHS and the Occupier.

3. Scope of Work

- a) To provide a baseline audit/assessment of the facilities with respect to fire safety management.
- b) To provide information to enable the facilities management to develop appropriate fire safety procedures.
- c) To train in staff and committee in occupational safety and health awareness and management
- d) Facilitate and ensure the registration of AAH Kenya

4. Methodology

The audits shall include but not limited to the following:

Workplace Safety, Health and Welfare Conditions

- a) Electrical safety;
- b) Fire safety;
- c) Construction safety;
- d) Office Safety;
- e) Road safety; and
- f) Machinery safety.

Occupational Health and Hygiene Conditions

- a) Personal Protective Equipment (PPE);
- b) Ventilation;
- c) Overcrowding;
- d) Housekeeping;
- e) Lighting;
- f) Handling of materials;
- g) Noise; and
- h) Vibration.

General Conditions

- a) General Conditions;
- b) Workplace efficiency;
- c) Storage, warehousing and handling; and
- d) Welfare facilities.

Any other relevant issues not listed above but stipulated in the procedure/ format for carrying out a safety and health audit.

5. Competence and Expertise Requirements

a) The firm should have been in operation for the last five (5) years, proven experience in offering similar services is essential. Be a Registered a trainer on Occupational Safety and Health by the Directorate of Occupational Safety and Health Services (DOSHS) and National Industrial Training Authority (NITA). A detailed profile along with the curriculum vitae of the Safety and Health Advisor/Auditors, to be involved in the assignment should be provided.

- b) The firm will be required to provide details of at least 3 similar studies undertaken in Kenya. The Consultant(s) should provide adequate information indicating that he/she is/are qualified to undertake the assignment successfully by providing the following information:
 - Description and experience in similar assignments; and
 - Availability of appropriate skills, competencies and qualifications among professional staff amongst others. This will enable AAH-I Kenya Programme short-list suitable Consultant(s) for the next stage of the selection process.

Key Qualification for Lead Safety and Health Advisor

- **Education:** At least a Master Degree in Occupational Safety and Health, Safety Engineering or equivalent from a recognized University.
- **Training**: Sound Background in Occupational Safety and Health and must have undergone training on Occupational Safety and Health Audits.
- Skills: Must possess communication skills both oral and written, presentations skills and auditing skills.
- Experience:
 - Must have a minimum of 8 years' experience in Occupational Safety and Health; and
 - Must have been a Safety and Health Advisor in at least 4 Projects.
 - Must be registered with Directorate of Occupational Safety and Health Services (DOSHS)
 as a Safety and Health Advisor and having a valid certificate.

6. Key Deliverables/Expected Outputs

The ultimate product for this Consultancy Service is to have Risk Assessment, Safety and Health Audit Reports, Fire Risks Audit Reports, Registration of AAH Kenya for the Kakuma and Kalobeyei Offices.
