

## RE-INVITATION TO BID – TRANSPORT SERVICES: TRANSPORTATION

### **Background**

AAH-I Kenya is inviting interested and qualified companies to submit bids for Provision of trucks for hire to transport its improved cookstoves from the manufacturer in Kisumu to the warehouse in Ewaso-Ngiro, Narok.

The capacity and the type of the truck is shown below. This is also for purposes of having framework agreement.

Type of vehicle	Specific duty
An FRR, 10mt	Transport stoves from the manufacturer in Kisumu to warehouse in Ewaso-Ngiro, Narok.
An FRR, 20mt	Transport stoves from the manufacturer in Kisumu to warehouse in Ewaso-Ngiro, Narok. In cases where the numbers of stoves being transported is many.

For transportation from Manufacturer to the warehouse: Quotes should indicate **a fixed price per trip for transportation from Kisumu to Ewaso-Ngiro, Narok.**

### **Important Note:**

Fuel, truck maintenance and driver's fee, is the responsibility of the truck Company.

### **1. REQUIREMENTS FOR THE BID**

#### **Administrative Requirement:**

Companies are required to submit the following documents;

1. Company Registration Certificate
2. Tax compliance certificate
3. Valid Business permit

4. Declare company's ownership- Attach Articles of Association (attach, the first 3 pages and signature page that has shareholding information OR CR12 form)

Only registered company will be evaluated.

#### **Technical Requirement**

1. Brief Overview of company (Company profile) including physical business address and postal address, should have list of vehicles owned by the company and their registration numbers.
  2. Must have evidence of past experience in road transport (attach copies of contracts implemented)
  3. Should share recommendation from at least 2 companies/organizations
  4. Must show evidence truck ownership (attach registration documents – copies of log books)
  5. Current bank statement
  6. Goods in transit insurance cover
2. **Price and Currency:** The prices shall be in Kenya Shillings.
  3. **Quotation should be on Company's letter head**
  4. **Location of the service:** Kisumu & Narok County
  5. **Language for the bids:** The language for the bids shall be **English** only. No handwritten bid will be accepted.
  6. **Submission of Quotes and deadline:**  
Bids documents prepared in English, will be sent to this email address [procurement@actionafricahelp.org](mailto:procurement@actionafricahelp.org) not later than **Thursday 26<sup>th</sup> September, 2024 at 03:00 pm local time**. Clearly indicate **"TRANSPORTATION SERVICES"** on the subject line of the email.
  7. **Request for clarifications**  
Any request for clarification must be made in writing through the email: [procurement@actionafricahelp.org](mailto:procurement@actionafricahelp.org) strictly and must be received not later than **Wednesday the 25<sup>th</sup> September, 2024 at 12:00 pm Local Time**.
  8. **Evaluation criteria**  
Evaluation will be based on administrative, technical and financial requirements. Bidders who will fail to submit any of the documents requested at administrative level will be disqualified from technical and financial evaluation.
  9. **Notification of the results**  
Only the successful and competitive bidder will be notified, and if you do not receive email communication within two weeks after the expiry of the deadline, consider your bid not successful.
